## 2020 SPECIALIST PAEDIATRIC SERVICES AT GENESIS CLINIC

Congratulations on the imminent arrival of your little bundle of joy! We would like to assist you by ensuring that your newborn is healthy before going home.

It is therefore a requirement that all of our babies are examined post birth to be screened for certain conditions that are present in the newborn period as well as any congenital abnormalities such as critical congenital heart disease. In the event of a caesarian section, a paediatrician is required to be present at the time of the caesarian section to ensure baby's safety. It is hospital policy that as long as the baby is at Genesis, they must be seen.

Dr Bopape-Chinyanga, our resident paediatrician, will be available for daily rounds for all of our newborns. Dr Bopape-Chinyanga is supported by our locum paediatricians who are available after hours and over the weekends.

### Paediatrician fees are as follows

You are required to **pay a deposit of R2,850** directly to the Paediatrician if you are a medical aid client. For private clients, this deposit is included in your deposit to Life Healthcare

### Medical aid clients

An invoice will be emailed to you for your medical aid claim after discharge. Any additional fees over and above your deposit will need to be settled on the day of discharge. If your fee is claimed directly with your medical aid, you will be liable for settling any amount not paid to us.

Should you wish to utilize Dr Bopape-Chinyanga's services post birth, please be advised that it is a cash practice. Dr Bopape-Chinyanga is available for consultation during the week from 08:00 until 16:00. Consultation fees is R1 600.
